

It is our great pleasure to announce the launch of a new section of the ANEM's web site, "ANEM Activities", which aims to regularly and comprehensively inform our colleagues, partners, donors and the public about ANEM's activities. Introduction of ANEM Intranet – During the spring/summer 2008 ANEM launched ANEM Intranet, a separate portion of ANEM's Website which is exclusively available to members and associated members of ANEM. This is a new service ANEM designed with the aim to facilitate and improve the communication and exchange of information and knowledge within the association.

The realization of ANEM Intranet has been financially supported by USAID through the program IREX ProMedia II Serbia.

ANEM expert analyses of situation in the media sphere – During the summer of 2008, in order to increase the role and activities of ANEM in the area of media policy and regulation reform, ANEM has implemented the project whose aim was to facilitate preparation of expert opinions and analyses of situation in the media. As a result, several publications have been released dealing with the topics such as the protection of the freedom of the media and journalists, financial sustainability of commercial media, preparation of media outlets for digitalization and corporate social responsibility. The preparation of analyses has been financially support by USAID through the program IREX ProMedia II Serbia.

Cooperation between ANEM and civil sector organisations – activities of the Group for Media Sector Reform – The Group for Media Sector Reform, consisting of representatives of the Independent Journalists' Association of Serbia (NUNS), Local Press and ANEM, is trying to effect the modification of the Law on Advertising to allow for better treatment of advertising messages of non-profit organizations informing citizens on charity, humanitarian and similar type campaigns. The initiative of the Group for Media Sector Reform has so far been supported by more than 35 civil sector organizations which have recognized the importance of the initiative and its effect on the media and the civil sector, as well as their cooperation in protection of public interest. Privatization and the media – During 2008, ANEM has initiated and organized several meetings with government officials, mechanisms for protection of human rights and representatives of local and international organizations active in the area of human rights and media freedoms, with the aim to systematically and thoroughly solve old but also new problems in the privatization of the media.
