### **1. ANEMova radionica za članice o finansiranju medija iz budžetskih sredstava**

## **7. Monitoring medijske scene u Srbiji**



### **ANEM Newsletter No. 16**

Dear colleagues and partners,

In the sixteenth issue of ANEM Newsletter, we draw your attention to a few latest activities of our Association. You can find information on all ANEM activities on our website [www.anem.org.rs](http://www.anem.org.rs), under the section *ANEM Activities*. Here, we bring you the highlights:

## **1. ANEM workshop for members on media funding from the state budget funds**

On January 27, 2011, ANEM organized in Belgrade a workshop on topic “Media funding from state budget funds and media market functioning”. To find out what the panelists, representatives from relevant authorities, local governments and ANEM stations said about this issue, as well as what were the conclusions of the discussion, read the report from the workshop [here](#).

## **2. ANEM suggestions on regulation of system for media funding from the state budget funds**

As another contribution to the development of a quality Media Strategy, on January 31, 2011, ANEM submitted to the Ministry of Culture its suggestions on regulation of system for media funding from state budget funds. The contents of these suggestions can be read [here](#).

## **3. Initiative for assessing the constitutionality of certain provisions of four legislations**

Because of the way the Law on local self-government, the Law on the Capital, the Law on National Councils of National Minorities and the Law on Protection of Rights and Freedoms of National Minorities regulate certain issues of importance to the media, namely in a different way from systemic media laws and the Constitution of the Republic of Serbia, ANEM submitted an initiative to the Constitutional Court on January 28, 2011, to assess the constitutionality of certain provisions of the said laws. ## **4. A Digitalization Guide for ANEM stations**

In order to help its stations to understand what the process of digitalization means for them, ANEM has prepared an internal Guide to the process of digitalization and delivered it to its members through the internal mailing lists and ANEM Intranet network. ## **5. TV series from ANEM production**

a) In January 2011, the audience of 27 ANEM TV stations had the opportunity to see eight episodes of the TV series “Recognize Europe” about examples of positive changes in local communities throughout Serbia. Their brief overview can be found [here](#). Each month, on ANEM web portal “[Better Serbia](#)”, you can find selected episodes aired during the previous month. You can also give your vote there for what you think is the best story of the month.

b) Four episodes of the January TV series “The Mirror of Power”, with four new stories about the problem of corruption in local communities in Serbia, were broadcast on 26 ANEM TV stations. ## **6. Broadcasting of the TV magazines “Step by Step”**

In January 2011, 25 ANEM stations aired four new magazines of the TV series “Step by Step”, each bringing three new stories from different parts of Serbia. The TV series is being prepared by A-media. ## **7. Monitoring the media scene in Serbia**

On January 21, 2011, ANEM released the results of the December legal monitoring of the media scene in Serbia, which you can read about in the [Eighteenth Monitoring Report](#). ## **8. ANEM statement on the occasion of filing motions against media by SOKOJ and OFPS**

After the organizations for collective protection of copyright and related rights, SOKOJ and OFPS, arbitrarily and without analyzing the merits, had filed or initiated the filing of dozens of lawsuits against the media, ANEM issued a statement urging the authorities to take prompt measures to protect the media from arbitrariness of these organizations.
