67. MONITORING IZVEŠTAJ DOSTUPAN NA SAJTU ANEM-a - MEDIJSKA SCENA SRBIJE U DECEMBRU 2015 -

U Izveštaju je obrađeno:

- **Sloboda izražavanja** – seksistički skandal ministra odbrane, ocene međunarodnih organizacija o stanju medijskih sloboda u Srbiji i Izveštaj Saveta za borbu protiv korupcije koji se bavi mogućim uticajem institucija javnog sektora na medije kroz plaćanje usluga oglašavanja i marketinga..
- **Implementacija postojećih propisa** – Zakon o javnom informisanju i medijima: kako su dodeljena sredstva na javnom konkursu za sufinansiranje projekata proizvodnje medijskih sadržaja u Gradu Beogradu, i mogući načini za rešavanje problema u oblasti projektnog sufinansiranja; kako pitanje informisanja na manjinskim jezicima rešiti na kvalitetan način. Zakon o elektronskim medijima: problemi u postupku izbora dva kandidata za mesto u Savetu Regulatornog tela za elektronske medije, na predlog udruženja koja se bave zaštitom dece i slobodom izražavanja; analiza Nacrta predloga strategije razvoja medijskih usluga i Nacrta uputstva koje se odnosi na vreme emitovanja rijalitija prisilnog okruženja.
- **Usvajanje novih zakona** – pravna analiza predloženih izmena Zakona o javnim medijskim servisima i Predloga zakona o privremenom uređivanju načina naplate takse za javni medijski servis, i problemi koji mogu nastati njihovim usvajanjem.
- **Rad nadležnih organa** – postupak kontrole koji je Zaštitnik građana sproveo u Komunalnoj policiji grada Beograda, kao i postupak kontrole koji je Poverenik za informacije od javnog značaja i zaštitu podataka o ličnosti sproveo u psihijatrijskoj klinici „Laza Lazarević”, a u vezi sa neovlašćenim objavljinjem podataka iz te klinike u programu TV Pink.
- **Proces digitalizacije** – Povodom odluke Regulatornog tela za elektronske medije da se pokrajinski javni servis više ne emituje iz lotmenta Avala, u Izveštaju se ukazuje na probleme koje takva odluka može proizvesti u praksi.
- **Proces privatizacije medija** – proces likvidacije JP Tanjug i status dozvola medija koji nisu privatizovani do 31. oktobra 2015. godine.
- **Zaključak Izveštaja** – šta je obeležilo medijsku scenu u Srbiji u decembru 2015, i šta su suštinski problemi u medijskom sektoru.

ANEM ODRŽAO OKRUGLI STO „EFEKTI PRIMENE MEDIJSKIH ZAKONA I DALJE SMERNICE ZA MEDIJSKU REFORMU“

Asocijacija nezavisnih elektronskih medija je, 29. januara 2016. godine, održala u Beogradu okrugli sto o efektima dosadašnje primene medijskih zakona, od njihovog usvajanja u avgustu 2014. godine. Skup je imao za cilj da okupi predstavnike medijskih i novinarskih udruženja, akademske zajednice, civilnog društva, nadležnih organa i drugih zainteresovanih strana, koji bi u međusobnoj razmeni mišljenja mapirali dosadašnje efekte medijskih zakona, i predložili smernice i preporuke za izmenu regulative i prakse, kako bi se na adekvatan način ispunili ciljevi koje je postavila Medijska strategija iz 2011. godine. 67th MONITORING REPORT OF ANEM IS AVAILABLE ON ANEM'S WEBSITE - SERBIAN MEDIA SCENE IN DECEMBER 2015 -

The Report contains analysis on the following topics:

- **Freedom of expression** – the sexist scandal of the Defense Minister, the assessment of international organizations about the situation of media freedoms in Serbia and the report of the Anti-Corruption Council about the potential influence of public sector institutions on the media through payments of advertising and marketing services.
- **Implementation of existing regulations** – Law on Public Information and Media: how were funds allocated on the open competition for the co-financing of media projects production in the City of Belgrade and the related ways to address the problems in the area of project co-financing; how to tackle the problem of minority media/information in minority languages in a successful manner. Law on Electronic Media: the problem in the election of two candidates for a position in the RBEM Council, at the proposal of associations engaged in the protection of children and freedom of expression; analysis of the Draft Blueprint of the Strategy for the Development of Media Services and the Draft Instructions concerning the time of broadcast of forced environment reality programs.
- **Adoption of new laws** – legal analysis of Amendments to the Law on Public Service Broadcasters and the Draft of the Law on the Temporary Regulation of the Collection of the Fee for the Public Service Broadcaster and the problems that might arise with the adoption thereof
- **Work of competent bodies** – the controlling procedure the Ombudsman conducted in the Communal Police of the Belgrade, as well as the control the Ombudsman for Information of Public Interest and Personal Data Protection carried out in the psychiatric clinic "Laza Lazarevic" in relation to unauthorized disclosure of data from that clinic on the air of TV Pink.
- **The Digitalization Process** – Regarding the decision of RBEM to cease broadcasting the provincial PSB from the Avala allotment, the Report points out to the problems such a decision may cause in practice.
- **The media privatization process** – the process of liquidation of the state-owned Tanjug news agency and the status of the licenses of the media outlets that haven't been privatized by October 31, 2015.
- **The Conclusion of the Report** – what marked the media landscape in Serbia in December 2015 and what are the key problems on the media landscape.

The Sixty-seventh Monitoring Report was prepared by the ANEM expert monitoring team from the law office „Živković&Samardžić“, in cooperation with ANEM.

ANEM HELD THE ROUND TABLE TITLED: "EFFECTS OF MEDIA LAWS IMPLEMENTATION AND FURTHER GUIDELINES FOR MEDIA REFORM"

On January 29, 2016, the Association of Independent Electronic Media held a round table in Belgrade on the effects of the implementation of media laws since their adoption in August 2014. *The round table aimed at gathering the representatives of media and journalists' associations, the academic community, civil society, competent authorities and other stakeholders, to map, in a mutual exchange of opinions, the effects of the application of media laws so far and propose guidelines and recommendations for changing the regulations, as well as the practice. The goal being to adequately fulfill the goals set in the Media Strategy from 2011. Conclusions and suggestions are available in the report on the event [here](#).*
